Professional Experience

Mr. Lian is the Founder and Head of Jadong IP Law Firm. Previously, he was also the Founder and Head of the Patent and Trademark Group of Hylands Law Firm as well as an IP investigation company, ABIDA.

He is a member of the first group of Chinese lawyers to emerge since China restored its lawyer system in 1979. From 1982 to 1985 he worked with CCPIT Legal Advisory Office, the predecessor of China Global Law Firm. From 1985 to 1996 he worked with CCPIT Patent and Trademark Law Office, during which time he worked for four years with CCPIT's Office in Canada and worked for few months in an Italian IP firm. From 1997 to 2001 he worked with C & M Law Firm as a co-founder, specializing in IP. From 2001 to 2017 he worked as senior partner with Hylands Law firm, specializing in IP. In early 2018 he founded Jadong IP Law Firm.

Since 1985 he has been practicing law in IP field for 35 years. His practice area includes trademark, copyright, unfair-competition, domain name and IP litigation. He has extensive experiences in trademark prosecutions, covering filings, oppositions, reviews, invalidations, cancellations and renewals. He also has extensive experiences in trademark prosecutions, covering anti-counterfeiting investigations, raid actions and litigations.

In respect of anti-counterfeiting service, he founded an anti-counterfeiting investigation company and set up anti-counterfeiting teams in Beijing, Guangzhou, Shenzhen and Shanghai, which successfully carried out thousands of investigations and raid actions against counterfeiters of many well-known international trademarks. Through raid actions under his management, many counterfeiters have been sentenced to imprisonment. He made "Brand Protection Package" for well-known international brands, which includes trademark applications, many anti-counterfeiting investigations, AIC raid actions, police raid actions, compensation litigations, infringement litigations and administrative litigations. He is recognized as an ant-counterfeiting expert both by the international brand owners and IP community in general. He has acted as a committee member of the Anti-counterfeiting Committee of INTA for two terms and moderated INTA's session on criminal actions against counterfeiters in China.

He has very good experience in making clients' trademarks recognized as well-known trademarks in both trademark prosecution and enforcement. He also made clients' trademark listed in the Well-known Trademark Protection List of AIC.

In respect of domain name service, he is a member of the first group of Chinese lawyers providing domain name services and set up a domain name service team. He is a panelist of the CIETAC Domain Name Dispute Resolution Center, the Asian Domain Name Dispute Resolution Center as well as Hong Kong International Arbitration Center. He has made more than 90 domain name decisions and gave presentations on domain names in national and international conferences, like AIPPI, conferences of Asia Domain Name Dispute Resolution Center, Hong Kong internet conference, first national conference on domain names as well as domain name panelist seminars. He is a frequent speaker in many international conferences, like INTA, AIPPI, MARQUES.

He founded and managed several IP service providers, like the Patent and Trademark Group of Hylands Law Firm, Jadong IP Law Firm and an IP investigation company, ABIDA.
